

Highlights

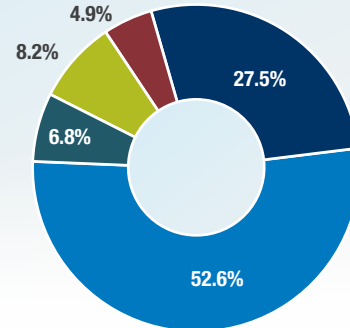

Fund Risks

Investments in mutual funds carry risks and investors may lose principal value.
