Market Cycle Performance reflects the two most recent market cycles (peak to peak) defined as a period that contains a decline of at least 20% from the previous market peak over at least a two-month period and a rebound to establish a new peak above the prior market peak. The current cycle is ongoing and thus presented through the most recent quarter-end. Once the cycle closes, the results presented may differ materially.

A redemption fee of 2% will be imposed on redemptions within 90 days.

First Pacific Advisors, LP (the "Adviser" or "FPA"), the Fund's investment adviser, has contractually agreed to reimburse the Fund for Total Annual Fund Operating Expenses in excess of 1.05% of the average net assets of the Fund, excluding short sale dividend expenses and interest expenses on cash deposits relating to short sales, brokerage fees and commissions, interest, taxes, fees and expenses of other funds in which the Fund invests, and extraordinary expenses, including litigation expenses not incurred in the Fund's ordinary course of business, through April 30, 2021. This agreement may only be terminated earlier by the Fund's Board of Trustees (the "Board") or upon termination of the Advisory Agreement.

Activity:¹

- Added long equity position in Epic Games and fixed income positions in Carnival Corporation and Royal Caribbean Cruises. As a result of the merger between United Technologies and Raytheon Technologies, received shares in Otis Worldwide.
- Increased the Fund's position in Marriott International.
- Decreased the Fund's position in Bank of America.
- Exited the Fund's long positions in Air Canada, JD.com, O-I Glass, Raytheon Technologies*, Tokyo Broadcasting System, Toyota Industries, and United Technologies*. Closed pair trade of Dupont de Nemours/International Flavors & Fragrances.

- The Fund's top three sectors are communication services, financials, and information technology, which comprise approximately 45% of the portfolio.
- Our net risk exposure increased slightly during the quarter. We continue to search for what we believe to be high-quality, value opportunities for inclusion in the portfolio, while remaining mindful of our long-term focus of limiting the permanent impairment of capital.
- While we increased our credit exposure near the end of Q1 2020 given the substantial increase in yields and spreads to Treasuries, we no longer believe that credit is as attractive as it was a few months ago. However, we believe that idiosyncratic stress in the high-yield market may be a fertile area of opportunity over the next several quarters.

The **S&P 500 Index** includes a representative sample of 500 hundred companies in leading industries of the U.S. economy. The Index focuses on the large-cap segment of the market, with over 80% coverage of U.S. equities, but is also considered a proxy for the total market.

The **MSCI ACWI Index**, is designed to represent performance of the full opportunity set of large- and mid-cap stocks across 23 developed and 24 emerging markets. It covers more than 2,700 constituents across 11 sectors and approximately 85% of the free float-adjusted market capitalization in each market.

Bloomberg Barclays U.S. Aggregate Bond Index provides a measure of the performance of the U.S. investment grade bonds market, which includes investment grade U.S. Government bonds, investment grade corporate bonds, mortgage pass-through securities and asset-backed securities that are publicly offered for sale in the United States. The securities in the Index must have at least 1 year remaining in maturity. In addition, the securities must be denominated in U.S. dollars and must be fixed rate, nonconvertible, and taxable.
