Activity:¹

- Univar purchased Nexeo Solutions and as a result the Fund received shares in Univar Inc. (UNVR).
- Increased the Fund's long equity exposure in JD.com.
- We decreased the size of the Fund's PG&E/Utilities Select Sector SPDR ETF hedged position. We also decreased the Fund's fixed income position in Bombardier.
- Closed the Fund's long equity positions in Expedia (EXPE), Ditech Holdings (DHCP), Oracle (ORCL), Surgutneftegas (SNGSP RM), and WPP PLC (WPP LN). We also closed our small fixed income position in Southwestern Energy.

- We decreased our net risk exposure by approximately 100 bps during Q1 2019 following strong equity market performance.
- The Fund's top three sectors are financials, communication services, and industrials, which comprise 40% of the portfolio.
- With volatility returning to the market, we continue to search for what we believe to be high quality, value opportunities for inclusion in the portfolio, while remaining mindful of our long-term focus of limiting the permanent impairment of capital.
- We still view high-yield bonds as unattractive given sub-par yields and spreads to treasuries as well as weak covenants.

Index Definitions

The **S&P 500 Index** includes a representative sample of 500 hundred companies in leading industries of the U.S. economy. The Index focuses on the large-cap segment of the market, with over 80% coverage of U.S. equities, but is also considered a proxy for the total market.

The **MSCI ACWI Index**, is designed to represent performance of the full opportunity set of large- and mid-cap stocks across 23 developed and 24 emerging markets. It covers more than 2,700 constituents across 11 sectors and approximately 85% of the free float-adjusted market capitalization in each market.

Bloomberg Barclays Aggregate Index provides a measure of the performance of the U.S. investment grade bonds market, which includes investment grade U.S. Government bonds, investment grade corporate bonds, mortgage pass-through securities and asset-backed securities that are publicly offered for sale in the United States. The securities in the Index must have at least 1 year remaining in maturity. In addition, the securities must be denominated in U.S. dollars and must be fixed rate, nonconvertible, and taxable.

The **Consumer Price Index (CPI)** is an unmanaged index representing the rate of the inflation of U.S. consumer prices as determined by the U.S. Department of Labor Statistics. The CPI is presented to illustrate the Fund's purchasing power against changes in the prices of goods as opposed to a benchmark, which is used to compare the Fund's performance.
