The CPI is an unmanaged index representing the rate of inflation of U.S. consumer prices as determined by the U.S. Department of Labor Statistics. The CPI reflects non-seasonally adjusted returns. Morningstar Analyst Rating (as of 7/14/2021)





Fund Risks
