

## Highlights

Primary investment objective is to seek to provide long-term total return, which includes income and capital appreciation, while considering capital preservation.

**Short-term:** seeks positive absolute returns in a 12-month period.

**Long-term:** seeks positive real returns (outperform inflation plus 100 basis points) over five-year period and competitive returns versus bond market universe.

- **Bottom-up, benchmark indifferent.**
- **Invest a minimum of 75% of net assets in securities rated A- and above (high quality segment).**
- **Opportunistic allocation (up to 25% of net assets) to credit sensitive securities rated BBB+ and below (credit sensitive segment).**
- **Cash allocation is a residual of investment opportunities.**

Effective July 1, 2020, the Adviser is temporarily reimbursing annualized Fund operating expenses in excess of 0.48% of the average net assets of the Fund (excluding interest, taxes, brokerage fees and commissions payable by the Fund in connection with the purchase or sale of portfolio securities, and extraordinary expenses, including litigation expenses not incurred in the Fund's ordinary course of business) until such time as the Fund's portfolio managers believe the waiver is no longer appropriate. When this temporary waiver is terminated, the Fund's expenses will be return to the contractual limit of 0.50% noted above.

## Fund Risks


