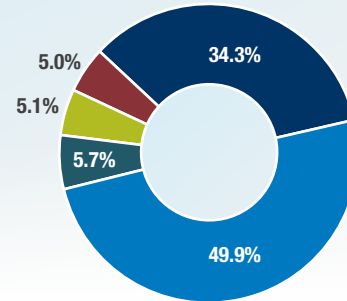

## Fund Risks
