2025 Year-End Capital Gain Estimates

The estimated ranges for capital gain distributions as of September 30, 2025 are listed below. Actual year-end distributions will be based on gains and losses realized through October 31. Estimated distribution rates on a per-share basis for dividend income will be available in December. The FPA Funds' longer-term approach to investing means that the capital gains realized in a particular year can be the result of an investment held over an extended period of time. The amount of capital gain distributions will vary year over year since the distributions are based on net capital gain realized each year.

Capital gains distributions are the net gains realized from the sale of fund securities. All registered investment companies periodically distribute profits they earn to investors. By law, if a fund has net gains from the sale of securities, or if it earns dividends and interest from securities, it must pass substantially all of those earnings to its shareholders or it will be subject to corporate income taxes and excise taxes. These taxes would, in effect, reduce investors' total return.

To receive a distribution, you must have been a registered shareholder of the applicable FPA Fund on the record date. Distributions are paid to shareholders on the payment date. Past distributions are not indicative of future results.

The estimates as of September 30 are estimates of the year-end capital gain distributions and are a snapshot of realized capital gains as of September 30. Because the year-end capital gain distributions will be based on capital gains realized through October 31, the actual distributions will vary from the estimates based on activity after September 30 and other tax adjustments.

The estimated distribution rates may be affected by numerous factors, including but not limited to changes in realized and projected market returns, fluctuations in market interest rates, fund performance, and other factors. There can be no assurance that a change in market conditions or other factors will not result in a change in the estimated distribution rate or that the rate will be sustainable in the future.
