#### Glossary of Terms

**Market Cycle Performance** Market Cycle Performance reflects the two most recent completed market cycles (peak to peak) defined as a period that contains a decline of at least 20% from the previous market peak over at least a two-month period and a rebound to establish a new peak above the previous one by S&P 500 Index. It also includes the current cycle, which is ongoing and thus presented through the most recent quarter-end. Once the current cycle closes, the results presented may differ materially and may reflect a different time period than shown here.

**Net Risk Exposure** is defined as the percentage of portfolio exposed to Risk Assets. **Risk Assets** include all investments excluding cash and cash equivalents.

**Contribution to return** is calculated by taking the Category Performance and multiplying it by the Average Weighting. **Average Weighting** is the average of asset segment (category) weights as a percentage of total portfolio at the end of the period and averaged for latest quarter, Year-to-Date, and calendar year. For example, to calculate the average weight for Common Stock Long, add the current quarter weight of and prior quarter weight and divide by 2 (observations) you get the average. The **Average Weighting for all the years listed** is a simple average of the values at each period end. For the **Average Weighting, Category Performance, and Index Performance** categories, data for 2007 and 2008 is available upon request.
