Dear Fellow Shareholders,

FPA Queens Road Value Fund ("Fund") returned 11.75% for the fourth quarter of 2023. This compares to the S&P 500 Value Index ("Index") return of -4.09% for the same period. For the full year of 2023, the Fund returned 16.06% while the Index returned 22.23%.

2023 was a strong year in the stock market. But most of the gain came in the last two months of the year – from October 28 through December 31, the S&P 500 Value Index returned 17.84%. The strong rally matched a decline in interest rates that saw the 10 Year yield decline from approximately 5% to 3.8% over that time period. All things being equal, low rates should be good for equity prices. But things aren't always equal and the current interest rates are just a point measurement in time. And so we will continue doing what we always do – looking bottom up for quality companies trading at reasonable valuations.

The market seems to have abruptly embraced the "soft landing" narrative.² This makes us uncomfortable – the economy grows in cycles and bad things can happen to good companies. When things are going badly, we know what we are dealing with. But when the everything is going well and securities prices reflect a rose tinted view of the future, we can only worry about what could go wrong.

We are having trouble normalizing the current operating environment. From reading earnings reports and call transcripts and talking to companies, it seems that company managers are struggling with this as well. It is not entirely apparent to what extent supply chain issues, inflation, government stimulus and post Covid consumer preferences are impacting trailing financials. At the same time, we are wary of the unprecedented rise in short-term interest rates. And we are beginning to see cracks in the robust post-Covid consumer environment.³

Although we run the Fund fully invested, and we love the companies that we own, we are having trouble finding new investments that meet our stringent Four Pillar process and provide a margin of safety. High quality industrials, a frequent hunting ground for the Fund, strike us as particularly richly valued right now given their inherently cyclical nature.

For the 12 months ending December 31, 2023, both losses and gains were well distributed. Although our two biggest winners, Eaton and Trane, are both industrials, Eaton sells electrical components and is benefitting from data center spending while Trane builds and services HVAC systems, mostly for large commercial and industrial properties. Similarly Intel, our third best performer, is a bit of a special situation as they try to revive their leadership in the design and manufacturing of core processing chips while Oracle is the large, incumbent, relational database provider that is evolving into the cloud.

Our 12 month detractors were led by three healthcare companies. Pfizer is a pharma company that is struggling with a hole in its future pipeline. Danaher is a best in class manufacturer of diagnostics and the tools used in drug discovery and life science research. The stock performed very well during Covid but is now struggling with a slowdown in in life sciences and biotech funding. And Elevance is a managed care company that is digesting cost inflation.

At its most basic, our process compares a company's current price to what we expect the business to look like three to five years out. Our four pillars – balance sheet strength, valuation, management, and industry analysis – provide guidance and guardrails. Taking a long-term view has served us well in the past and we are confident that our disciplined and patient approach will continue to be rewarded over the long-term.

In our experience, when there is exuberance in the markets, it is usually overdone. But when markets get volatile and the pundits predict doom and gloom, it is usually overdone as well. We acknowledge the heightened uncertainty as well as the headwinds the economy faces. But, given the current valuations and long-term fundamentals of the Fund's holdings, we feel more positive about the portfolio than we have in several years.
